# How it works?

It's very straight forward:

1. Select a cause/organisation that you would like to be considered for funding.
2. Nominate them by filling out the attached form and hand it into your local EBS office.
3. A group of volunteer members and staff will meet to select the successful causes.
4. Once the causes have been selected, we will be in touch to let you know the results.

# What you need to tell us

- In considering who you are going to nominate, please remember that they must be a non profit organisation and run at a local level.
- Give as much information as you can about why the organisation is so important both to you and to your community.
- If you know a specific project that the cause/organisation is running for which they require money, please give as much details about the project as you can.
- The maximum for any one donation will be €5,000, however EBS would like to support as many causes as we can and therefore the amounts will vary.
- Ideally, we would like you to keep the information within the space on the application form however should you wish, you may attach additional detail to the back of the form.

**Terms and conditions:** To nominate your cause, submit a completed application form to your local EBS office. You must be a member of EBS Building Society. EBS reserves the right to confirm whether an applicant is a member of the Society. This scheme is not open to employees of EBS. Only one application is permitted per member however a cause may be nominated more than once. The closing date for receipt of completed application forms is 5pm Friday the 5th of June 2009. It is not necessary to submit any supporting material with your application. Causes that may be nominated must be Irish based and national causes may not be nominated. Applications must satisfy the criteria of the EBS Community Fund Programme. The value of the wards given to each successful cause are the discretion of EBS, their decision is final. Successful and unsuccessful applicants will be notified by EBS from the end of June. Cheques will be issued to the successful cause. Any legal or taxation issues arising from any successful causes acceptance of an award is a matter for the successful cause. EBS may request that members feature in communications about the fund. Information collected from this application form may also be used for this purpose. The operation of the EBS Community Fund, including the level, number and timing of any awards is a matter solely of EBS. The decision of EBS is final and binding on applicants. No correspondence will be entered into. No alternative award will be offered. Following a successful nomination the member may nominate another cause for the next round of nominations and thereafter. Notwithstanding that if a member/successful cause has been notified, if EBS should discover before the distribution of the award that for any reason under these terms and conditions that a cause or applicant should have been ineligible to be entered into the EBS Community Fund, or if the entry should have been declared invalid, EBS reserves the right to determine that the applicant is disqualified.
